

SRI VENKATESWARA DENTAL COLLEGE & Hospital hereinafter referred to as Sri Venkateswara Dental College & Hospital and, Saveetha Dental College And Hospitals hereafter referred to as SIMATS considering their common interest in promoting the mutual cooperation in the area of education and research, wish to expand the basis for friendship and cooperative educational exchange, agreed the following Memorandum of Agreement (MOU)

Article | Purpose

The purpose of this MOU is to develop strong Collaboration in Academics and Research between two institutions

Article II: Scope of the Cooperation

Both parties undertake to promote and develop academic cooperation as follows

- 1 Exchange of academic and administrative staff and students.
- 2 Extension of students' learning opportunities.
- 3. Cooperation in research and the presentation of its results.
- 4 Exchange of academic materials, publications and other scientific information
- 5. Other educational and academic exchanges to which both universities agree

Article III: Financial Arrangement

- 1. Both parties agree that all specific arrangements and plans for activities are to be negotiated and are dependent on the availability of funds
- 2. Both parties agree to feasibly seek financial support from national and international organizations for the cooperative activities to be undertaken as stated under the terms of this MOU.

Article IV: Agreement of Implementation

A detailed description of the scope of activities shall be defined in the Agreement of implementation, which constitutes an integral part of this MOU

The Agreement of Implementation will include such items as:

- 1. Elaboration of the responsibilities of each institution for the agreed activities
- 2 Schedules for specific activities.
- 3 Budgets and financial sources for each activity.
- 4 Any other items deemed necessary for the efficient management of the activities

Article V: Intellectual Property Rights and Publication

- 1. The parties will share all data and research findings, and respect patent rights, copyrights, and other intellectual property rights regarding any discoveries, inventions and products resulting from this MOU.
- Both parties must give written approval for the utilization and publication of the data and research findings.
- 3 Detailed arrangement of finding and their Intellectual Property Rights and Publication shall be defined in the Agreement of Implementation.

Arts in VI Settlement of Differences

Article VII: Amendments, Duration and Termination

- 1 Amendments to this MOU can only be made by mutual consent for the two parties.
- 2. This MOU shall be in effect from the date of its signature and be valid for the duration of five (5) years from that date, and will be automatically renewed on an annual basis thereafter, unless terminated or replaced with a new MOU.
- 3. This MOU may be terminated by either party by written notice at least six (6) months prior to the termination date. Such notice of termination will not interfere with cooperative programs currently underway. Such programs will be allowed to continue until their conclusion.

This MOU is prepared in English and in Two (2) copies. Copies shall be deemed as authentic ones, either of which be kept by each party. As witness to their consent this MOU, the appropriate authorities hereto provide their signatures:

MEMORANDUM OF UNDERSTANDING

- 1 The agreement is signed between the Chief Medical Officer of MEDAVAKKAM Upgraded Govt.Primary Health Centre, Chingleput District, hereinafter called First party and the Sri Venkateswara Dental College and Hospital, Thalambur, Chennai 600130, hereinafter called Second party on this 10th Day of June 2020. The Second party agrees to provide the following service to the PHC with the following terms and conditions.
- 2. Whereas the upgraded Medavakkam Primary Helath Centre, Madavakkam, has requested firms/companies to provide the following infrastructure/service at the Upgraded Govt. Primary Health Centre, MEDAVAKKAM at their own cost and to display their Boards as mutually agreed upon in the determined size and agreed to this to provide the same.
- 3. Whereas the SRI VENKATESWARA DENTAL COLLEGE & HOSPITAL, THALAMBUR, CHENNAI agrees to maintain the Landscape Area at Upgraded Govt. Primary Health Centre, Medavakkam for a period of Five years and also requested to display their board in the premises of the Upgraded Govt. Primary Health Centre, Medavakkam

THIS INDENTURE WITNESS:-

- (a) In pursuance of the above, the request of CMO has been considered and SRI VENKATESWARA DENTAL COLLEGE & HOSPITAL, THALAMBUR, CHENNAI has agreed to provide quality dental treatment and procedures to the patients reporting at the Primary Health Centre requiring dental treatment
- (b) The CMO hereby permits SRI VENKATESWARA DENTAL COLLEGE & HOSPITAL, THALAMBUR, CHENNAI to provide DENTAL TREATMENT in MEDAVAKKAM Upgraded Govt. Primary Health Centre/Hospital for a period of FIVE years.
- (c) SRI VENKATESWARA DENTAL COLLEGE & HOSPITAL, THALAMBUR, CHENNAI agrees to maintain the Landscape by employing required personnel for the Upgraded Govt. Primary Health Centre, Medavakkam for the purpose

Primary Health Centre, MEDAVAKKAM when the Infrastry for the provided of Upgraded Govi

- 5 Once in a quarter the representatives of both parties shall jointly inspect to assess the service being provided Upgraded Govt. Primary Health Centre, MEDAVAKKAM.
- 6 Upgraded Govt. Primary Health Centre, MEDAVAKKAM agrees to display their boards of size 18" x 9 at the locations mutually agreed upon, and also one board size 2' x 6' to display in front of the entrance of the Upgraded Govt. Primary Health Centre, MEDAVAKKAM. However, the second party agrees not to display and political/religious slogans, etc on such publicity board
- In the event of inability to maintain the required service, the Medical Officer in charge
 of the Upgraded Govt. Primary Health Centre, MEDAVAKKAM may terminate the MOU
 after communicating the reasons to the second party. The publicity boards if any, will
 then be removed.
- 8. This agreement shall come to an end on the 9th Day of June 2025.
- This agreement may be renewed with Mutual consent for a further period of Five more years
